Natural Bridge Soil and Water Conservation District

Annual Report 2024-25

The Natural Bridge Soil and Water Conservation District was formed in 1939 and is the fourth oldest district in the state. In the Fall of 2025, the district will celebrate its 86th Anniversary of service to the citizens of Rockbridge County. The Natural Bridge SWCD joins 47 other Soil and Water Conservation Districts across the state of Virginia, and similar districts nationwide.

A soil and water conservation district is a governmental subdivision of the state which is responsible for conservation work within its boundaries. The purpose of this subdivision is to focus attention on land, water, and related resource problems. Soil and Water Conservation Districts enlist and coordinate help from public and private sources to deal with local conservation issues and provide technical expertise to assist the community in protecting its natural resources.

The purpose of the SWCD is to give citizens the structure and the capability to solve conservation problems at a local grassroots level. The idea of forming local conservation districts grew out of public concern for the conditions of our Natural Resources in the early 1930's. Poor farming practices, abuse of farmland, and unusually harsh weather caused massive soil erosion. The incentive for such problem solving began with the Dust Bowl/Depression era when people began to realize that land and water were precious resources to be carefully managed.

The Natural Bridge Soil and Water Conservation District was formed in 1939 and included the two magisterial districts of Botetourt and Rockbridge County. Later the city of Buena Vista joined the district. In July 1987, district boundaries were realigned. At that time the city of Lexington became part of the district. The present Natural

Bridge district includes Rockbridge County, the city of Buena Vista and the city of Lexington.

The Natural Bridge District covers over 605 square miles (approximately 387,324 acres), and includes Rockbridge County and the Cities of Lexington and Buena Vista. The District is flanked by the Alleghany Mountains on the west, and the Blue Ridge Mountains on the east. The county of Rockbridge is located midway in the Shenandoah Valley of Western Virginia and is accessible by interstate highways 81 and 64.

Grants and Partners

<u>Virginia Agricultural Best Management</u> <u>Practices Cost-Share Program</u> Program Year 2025

The District is responsible for administering the Virginia Agricultural BMP Cost-Share Program in Rockbridge County. The Virginia Department of Conservation and Recreation funds this program through the Water Quality Improvement Act and other state sources. These cost-share funds provide an incentive to agricultural producers and landowners to apply beneficial BMPs to their lands for more effective control of sediments, nutrient losses, and transport of pollutants into streams and waterways.

During program year 2025, the Natural Bridge SWCD completed 52 Best Management Practices. Producers were paid \$952,316.18 for these BMPs. Within these totals:

- 1 CCI maintenance practice protecting 1300 feet of streambank fencing was paid \$3,125.00.
- 1 FR-1 tree planting practice involving 4 acres was paid in the amount of \$13,497.60.

7 stream exclusion projects protected 30,960 feet of stream bank and were paid \$756,603.86 in cost-share dollars.

- 6 SL-1 cost-share practices were completed for the establishment of grass and legume vegetation on cropland to reduce soil erosion and enhance water quality. Practices paid totaled \$40,272.82.
- 37 SL-8B and SL-8H cover crop BMPs involving 2,780.7 acres were completed and paid \$138,816.90.

In addition, nearly \$1,308,200.71 has been obligated to approved BMP practices and will be carried over into cost-share program year 2026.

District Operations

The Natural Bridge SWCD Treasurer, along with the Finance Committee, oversee the operating budget. The budget includes administration of funds for education, sponsorships, special grants, programs and general operating expenses. The District receives support funding from the Virginia Department of Conservation and Recreation, and from the County of Rockbridge and the cities of Lexington and Buena Vista. During the process. monthly accounting reports generated, tracking the multiple programs and grants the District administers. The Natural Bridge SWCD is audited every two years to ensure the proper use of funds. Letters to request support funding from the local entities

served by the district are submitted to the three localities in January of each year, prior to the new fiscal year which begins July 1.

Strategic Plan for 2025-2028

The Natural Bridge SWCD works from a long-term strategic plan. Annual planning of district operations involves other agencies, organizations and/or individuals and enlists their continuing participation beyond plan development. A new strategic plan was developed in the Fall of 2024 and was unanimously adopted by the board of directors on December 18, 2024. The new strategic plan will serve, in part, as a guide for the district's work for the next 4 years. It will translate to a district annual plan of work with specific objectives. These objectives from the annual plan are reflected in the operational budget.

TMDL Watershed Implementation Grants

The Natural Bridge SWCD, in partnership with the Virginia Department of Environmental Quality (VADEQ), and other local agencies work together to plan strategies for local TMDL implementation. Discussions and collaborative meetings take place for plan development as the need arises. As appropriate for each individual TMDL implementation, cost-share is available for practices such as: livestock exclusion, improved riparian areas, afforestation of crop, hay, and pastureland, permanent vegetation cover on critical areas, pasture management as well as residential BMPs for septic tank pump out and septic repair systems.

2025 Upper James River Roundtable/RC&D

The Natural Bridge SWCD is lead district, sponsor, and fiscal agent for the Upper James RC & D. In May 2025, a grant agreement was signed by the board for funding through the VA Department of Environmental Quality (VDEQ) in the form of a support grant to continue the work of the original Upper James Roundtable. The Upper James RC&D (Resource Conservation and Development Council) serves the regions of Rockbridge, Alleghany, Bath, Highland, Botetourt, and Craig Counties and the cities within. Various public meetings and natural resource workshops are sponsored by the Upper **James** Roundtable/Upper James RC&D and supplies conservation grants in the form of sub-awards to local partnering agencies and grassroots groups. The current grant provides for administration and reporting of activities, invasive species removal and native planting, and educational outreach in the Upper James Watershed providing workshops to share information about the benefits of

conservation easements and other land conservation practices. The grant will also fund a Kids Fishing Day at the Natural Bridge State Park on Cedar Creek, an Upper James River tributary. The creek will be stocked with trout ahead of the event and will provide an educational opportunity for youths to learn about the importance of maintaining clean waters in our rivers. A cooking demonstration will offer participants the chance to have the trout they caught grilled on an open-air Two partner meetings and landowner fire. outreach events in the Upper James watershed will allow for a connection with landowners to convey the benefits of conservation easements. A beginner-friendly paddle and float conservation stakeholders will be available in August on the Upper James River near Buchanan. This event will provide conservation networking and capacity-building for participants as well as promotion of the BMP cost-share program. Grant projects will be completed by the end of 2025, with a total budget of \$14,276.

Educational Outreach

The SWCD formed a partnership with Boxerwood to recruit and train high school students for an Envirothon team. During their after school sessions, team members learned about the five Envirothon topics of study: forestry, aquatics, wildlife and the special topic. The team was coached by Ginny Johnson, assisted by Caterina Contreras. Team members participated at the Area I Envirothon Competition held on April 29, 2025 at McCormick Farm in Raphine. The event was hosted by the Natural Bridge SWCD and the Mountain Castles SWCD, in partnership with the staff of McCormick Farm, (AREC). This year, the students created and delivered a presentation to address the Envirothon special topic: "Roots and Resiliency: Fostering Forest Stewardship in a Canopy of Change". participation challenged the students by providing opportunities for research of potential solutions to problems posed by timber harvesting and management, climate change impacts, soil health and other related topics. The district looks forward to working with Boxerwood and these dedicated students during the coming school year.

Other speakers for the event were JB Daniel, State Grassland Agronomist with NRCS and Keith Tuck a producer sharing his first-hand knowledge of using warm season grasses within his grazing system. The 2024 Clean Water Farm Award was presented to Gavin Worley of Worley Mountain Farms. The farm owns and operates 49 acres on the south side of Rockbridge County and is dedicated to grazing livestock. The farm currently has 25 cow/calf pairs and is very active in conservation practices including: stream exclusion, forage and biomass planting, herbaceous weed control, and rotational grazing to help control erosion and stockpile grasses.
